Request Action:

Select and approve an appointee to replace Don Giancoli on the Police Pension Board.

Need Summary Explanation/ Background:

On November 10, 2025 the City Commission approved Resolution No. 25R-11-210, which appointed Andrea Anderson and Don Giancoli, by the Commission as a Whole, to serve on the Lauderhill Police Officers Retirement Trust Fund Board of Trustees. According to Florida Statute 185.05(1)(a), members of the board of trustees appointed by the legislative body must be legal residents of the City. Mr. Giancoli is not a resident of Lauderhill and, thus, is not eligible to be appointed to the board. A new appointee must be selected.

It is the recommendation of the City Manager that the Commission select Yolán Todd to fill this seat, as City Manager Hobbs previously held this position until the expiration of his term.
