A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARDED RFP 2025-050 – BUILDING DIVISION: INSPECTION & PLAN REVIEW SERVICES TO C.A.P. GOVERNMENT, INC., A BUREAU VERITAS COMPANY; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE SELECTED FIRM FOR AS-NEEDED PLAN REVIEW, INSPECTION SERVICES, AND PERMIT TECHNICIAN SUPPORT; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.)

WHEREAS, the City of Lauderhill requires the services of qualified, licensed firms to provide as-needed plan review, inspection services, and permit technician support for the Building Division; and

WHEREAS, to address this need, the Purchasing Division issued RFP 2025-050 – Building Division: Inspection & Plan Review Services, seeking qualified vendors capable of performing services across all building disciplines, including structural, mechanical, electrical, plumbing, roofing, landscaping, and 30-, 40-, and 50-year safety inspections; and

WHEREAS, this solicitation ensures uninterrupted service delivery during periods of high demand, employee absences, vacancies, or workload surges, and requires that all personnel meet State of Florida and Broward County Board of Rules and Appeals licensing requirements; and

WHEREAS, the evaluation committee has reviewed the RFP responses and recommends award to C.A.P. Government, Inc., a Bureau Veritas Company, which has demonstrated the qualifications, technical capacity, and staffing resources necessary to meet the City's needs; and

WHEREAS, funding for these services is available within the Building Division budget, and annual expenditures will vary based on actual service demands but shall not exceed budgeted appropriations; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitals are true and incorporated herein.

SECTION 2. The City Commission hereby awards RFP 2025-050 – Building Division: Inspection & Plan Review Services to C.A.P. Government, Inc., a Bureau Veritas Company, and authorizes the City Manager to execute an agreement with the selected firm for the provision of as-needed plan review, inspection services, and permit

technician support in accordance with the staffing classifications, scope, and hourly rates submitted in the firm's proposal.

SECTION 3. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
