THE CITY OF LAUDERHILL SOLICITED PROPOSALS FROM INTERESTED PARTIES FOR JAMES BRADLEY PARK IMPROVEMENTS SERVICES. SIX FIRMS RESPONDED TO THE SOLICITATION AND THE EVALUATION COMMITTEE RANKED THE SUBMITTALS AND RECOMMENDED AS FOLLOWS:

1. BEJAR CONSTRUCTION
2. WAYPOINT CONTRACTING, LLC.
3. SAGARIS CORP.
4. STONEHENGE CONSTRUCTION
5. WEST CONSTRUCTION INC.
6. BOROMEI CONSTRUCTION

IN THE EVENT THE TOP RANKED FIRM IS UNABLE TO MEET THE NEEDS OF THE CITY OR THE CITY MANAGER IS UNABLE TO NEGOTIATE A CONTRACT, STAFF WILL CONTINUE TO THE NEXT FIRM UNTIL THE RANKED LIST HAS BEEN EXHAUSTED.
