

RESOLUTION NO. 25R-07-133

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA AUTHORIZING AN AGREEMENT WITH DUVAL FORD, LLC FOR THE PURCHASE OF THREE (3) FORD MAVERICK PICKUP TRUCKS BASED ON A PIGGYBACK FROM THE FLORIDA SHERIFFS ASSOCIATION COOPERATIVE PURCHASING PROGRAM CONTRACT NO. FSA24-VEL32.0; AUTHORIZING PAYMENT IN AN AMOUNT NOT TO EXCEED \$100,326.00; PROVIDING THE CITY MANAGER WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR).

WHEREAS, pursuant to the City's Procurement Code, the City of Lauderhill ("City") may purchase vehicles and other equipment through the piggyback process; and

WHEREAS, the City of Lauderhill wishes to purchase three (3) Ford Maverick Pickup Trucks 4x2 vehicles from Duval Ford, LLC through the Florida Sheriffs Association Cooperative Purchasing Program; and

WHEREAS, the City Commission of the City of Lauderhill believes it is in the best interest to purchase three (3) Ford Maverick Pickup Trucks 4x2 vehicles via a piggyback through the Florida Sheriffs Association Cooperative Purchasing Program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the City Commission of the City of Lauderhill authorizes an agreement with Duval Ford, LLC for the purchase of three (3) Ford Maverick Pickup Trucks 4x2 vehicles through a piggyback from the Florida Sheriffs Association Cooperative Purchasing Program Contract No. FSA24-VEL32.0, in an amount not to exceed \$100,326.00.

SECTION 2. That the City Manager is authorized to do all things to effectuate this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
