

ORDINANCE NO. 240-09-144

AN ORDINANCE AMENDING THE CODE OF ORDINANCES CHAPTER 21, WATER AND SEWER SERVICE, ARTICLE IV, DEPARTMENT OF ENVIRONMENTAL AND ENGINEERING SERVICES RULES, REGULATIONS, AND RATES; AMENDING SECTION 21-47, SCHEDULE OF RATES AND CHARGES, TABLE 7, STORMWATER MINIMUM CHARGE/AVAILABILITY CHARGE; AMENDING THE STORMWATER RATE STRUCTURE EFFECTIVE COMMENCING OCTOBER 1, 2024; PROVIDING FOR FINDINGS AND CONCLUSIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, that the City Commission has determined that the following rates are just and equitable and are reasonable and necessary in relation to the services being provided;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the City of Lauderhill Code of Ordinances Chapter 21, Water and Sewer Service, Article IV. Department of Environmental and Engineering Services Rules, Regulations and Rates, Section 21-47, Schedule of Rates and Charges, Table 7, Stormwater Minimum Charge/Availability Charge is hereby amended to be effective October 1, 2024, to read as follows:

Sec. 21-47. - Schedule of rates and charges.

- (g) *Stormwater minimum charges/availability charges.* A fixed charge per service for each ebu connected to the system without regard to the amount of usage, including zero (0) amount shall be as follows. Commencing December 1, 2007, and effective on the 1st of October of each year thereafter, all stormwater minimum charges/availability rates will be adjusted automatically in accordance with one hundred (100) percent of the U.S. Department of Labor Consumer Price Index as determined in June of the calendar year of adjustment, unless indicated otherwise.

SECTION 3. That the rates contained herein shall take effect commencing upon passage of this Ordinance on October 1, 2024.

SECTION 4. This Ordinance shall take effect immediately upon its passage.
