### Text of Legislative File 23R-5082

#### Request Action:

A resolution is needed to waive competitive bidding and approve the sole source designation for Alternative Support Apparatus LLC (ASAP) to purchase two (2) off-road ambulance vehicles for the Fire Department.

**Need:**

Approval is needed to purchase two (2) off-road ambulance vehicles to aid in the quick and safe rescue of individuals in areas that traditional rescue vehicles would otherwise not be able to navigate through, such as crowds, offering to access hard-to-reach off-road locations.

**Summary Explanation/ Background:**

Alternative Support Apparatus LLC (ASAP) is the only company in the world building the ASAP MedStat off-road ambulance vehicle with a fully enclosed patient compartment.

Investing in the vehicles helps improve the safety standards across the board. This investment will allow fire rescue to respond quickly when an emergency warning unfolds at events or in tight areas a traditional EMS truck cannot fit.

The ASAP MedStat is the only UTV-based off-road ambulance vehicle with a US Patent (Patent No. 8,215,422 B2). This vehicle works hand-in-hand with the city's full-size ambulance and EMS fleet by providing a climate-controlled enclosed environment for the patient, securely housing a full-size cot, and seating up to two attendants and a driver. It also features a dedicated battery system to ensure the power you need for the scene, search, and emergency lights. The ASAP MedStat can meet your needs with its numerous standard features and an extensive list of options.

ASAP and Intimidator UTV products are all made in the United States of America, which supports the Federal government Buy American Act.
