<u>Section 4</u>. Approving the total budget adjustment in the amount of \$9,477,549.00.

<u>Section 5.</u> All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herein be and the same are hereby repealed as to the extent of such conflict.

<u>Section 6</u>. This Ordinance shall take effect immediately upon its passage.
