

**ORDINANCE NO. 250-06-121**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL AMENDING THE CODE OF ORDINANCES, CHAPTER 6, BUILDINGS AND BUILDING REGULATIONS, ARTICLE II, PUBLIC ART PROGRAM, SECTION 6-34, PUBLIC ART FUND, CLARIFYING AUTHORIZED USES OF THE FUND TO INCLUDE CAPITAL EXPENDITURES FOR THE ENHANCEMENT OF THE LAUDERHILL PERFORMING ARTS CENTER; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, KENNIE HOBBS).**

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the City of Lauderhill Code of Ordinances, Chapter 6, Buildings and Building Regulations, Article II, Public Art Program, Section 6-34 Public Art Fund, is hereby amended to read as follows:

**Sec. 6-34. Public Art Fund.**

(b) The public art fund shall be used solely for expenses associated with the selection, commissioning, acquisition, transportation, maintenance, promotion, administration, removal and insurance of the works of art or ~~in relation thereto~~ capital expenditures for the enhancement of the Lauderhill Performing Arts Center. Expenditures are to be authorized by the city manager or his/her designee.

SECTION 2. All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed as to the extent of such conflict.

SECTION 3. This Ordinance shall be deemed to have taken effect upon adoption.
