

**RESOLUTION NO. 21R-08-189**

**A RESOLUTION APPROVING THE WAIVER OF COMPETITIVE BIDDING; APPROVING THE CONTRACTS WITH GREENSOURCE LANDSCAPING AND SPORTS AND WITH BRIGHTVIEW LANDSCAPING SERVICES, BASED UPON THE BIDS SOLICITED BY THE CITY OF WESTON (RFP 2019-13), TO PROVIDE TURF RENOVATION, IRRIGATION REPAIR WORK, ROUTINE SODDING, LANDSCAPING, AND IRRIGATION REPAIR AS NEEDED; PROVIDING FOR PAYMENT ON AN AS NEEDED BASIS FROM THE APPROPRIATE BUDGET CODE NUMBERS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Weston (RFP 2019-13) solicited bids for landscaping and irrigation and has recommended the award of the bid to various vendors including Greensource Landscaping and Sports and Brightview Landscaping Services; and

WHEREAS, the City of Lauderhill has reviewed the bids solicited by the City of Weston and wishes to award the bids to these vendors to provide landscaping and irrigation services on an as needed basis; and

WHEREAS, the City Commission has determined that the award of contracts for these services, as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of bid to Greensource Landscaping and Sports and Brightview Landscaping Services on an as needed basis, based upon the bids solicited by the City of Weston (RFP 2019-13), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Payment in a total amount not to exceed a total of \$250,000.00 shall be made from the appropriate Budget Code Numbers.

Section 4. This Resolution shall take effect immediately upon its passage.
