Text of Legislative File 12R-2203

Request Action:

Amend the City of Lauderhill Code or Ordinances, Section 19-1 to include the City's current investment policy which was adopted by the City Commission and put into effect on September 14, 2011, but which inadvertently was not codified at that time as an amendment to the corresponding code section.

Need:

To update the Code of Ordinances to include the current version of the City's investment policy.

Summary Explanation/ Background:

It has come to our attention that when Ordinance No. 11O-08-157 was passed adopting the City's new Investment Policy, that it should have also been codified as an amendment to the City Code of

Ordinances Section 19-1. This Ordinance codifies the amendment to Code Section 19-1 which was intended to have been approved via backup to Ordinance No. 11O-08-157. The City's current investment policy became effective September 14, 2011.
