**Request Action:**

A RESOLUTION IS REQUIRED FROM THE CITY COMMISSION APPROVING THE WAIVER OF COMPETITIVE BIDDING AND CONSENTING TO PIGGYBACK ON THE STATE OF FLORIDA'S QUALIFIED VENDORS LIST OF IT PRODUCTS & SERVICES, STATE TERM CONTRACT 43210000-US-16-ACS BEGINNING MAY 1, 2016 THROUGH APRIL 30, 2019.

**Need:**

ACTION IS NEEDED FOR APPROVAL TO PURCHASE TECHNICAL GOODS AND SERVICES ON AN AS NEEDED BASIS DUE TO AN ONGOING NEED FOR IT PRODUCTS & SERVICES FOR THE CITY'S INFORMATION SYSTEMS INFRASTRUCTURE.

**Summary Explanation/ Background:**

MULTIPLE AGENCIES PROVIDE IT PRODUCTS AND SERVICES, INCLUDING BUT NOT LIMITED TO, DESKTOP COMPUTERS, PRINTERS, AND LAPTOPS. SECTION 2-144 OF THE CODE PROVIDES THAT THE CITY OF LAUDERHILL MAY JOIN WITH OTHER UNITS OF GOVERNMENT ON COOPERATIVE PURCHASING PLANS WITHOUT BIDS WHEN THE BEST INTEREST OF THE CITY WOULD BE SERVED.

BY UTILIZING THE STATE CONTRACT, IT ENABLES THE CITY TO OBTAIN BUYING POWER TO LOWER TOTAL COSTS AND REDUCE ADMINISTRATIVE BURDEN. WITH THIS, STAFF SEEKS APPROVAL OF THE TECHNOLOGY PRODUCTS, SERVICES, SOLUTIONS AND RELATED PRODUCTS AND SERVICES PROCURED THROUGH THE STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES CONTRACT NO. 43210000-US-16-ACS.
