### Summary Explanation/ Background:

STAFF IS RECOMMENDING APPROVAL OF THE SOLE SOURCE DESIGNATION FOR THE FOLLOWING COMPANIES THAT PROVIDE THE UTILITIES DEPARTMENT WITH KEY SUPPORT AND SERVICE. ACCORDINGLY, THESE COMPANIES FACILITATE THE REPAIR AND MAINTENANCE OF SPECIALIZED AND ESSENTIAL EQUIPMENT AND SOFTWARE. AS SUCH, APPROVAL OF THIS RESOLUTION WILL PROVIDE VARIOUS CITY DEPARTMENTS WITH APPROVAL OF THE SOLE OR SINGLE SOURCE STATUS FOR THESE COMPANIES:

(2) ALTEC INDUSTRIES, INC: AUTHORIZED DEALERSHIP IN THE STATE OF FLORIDA FOR SALES, PARTS, AND SERVICE IN THE STATE OF FLORIDA FOR AERIAL DEVICES.
