Request Action:

A RESOLUTION IS REQUESTED FROM THE CITY COMMISSION TO WAIVE COMPETITIVE BIDDING REQUIREMENTS AND APPROVE THE PURCHASE OF A MEGA SPAN SHADE STRUCTURE/AWNING AT RUTH ROTHKOPH PARK AS PART OF THE GO BOND IMPROVEMENTS.

ACTION IS NEEDED FOR THE ACCEPTANCE OF THE PROPOSAL FROM SUPERIOR PARK SYSTEMS, INC. REGARDING OBLIGATORY ENHANCEMENTS UNDER THE GO BOND PROGRAM.

Summary Explanation/ Background:

APPROVAL TO PIGGYBACK ON THE SCHOOL DISTRICT OF PALM BEACH CONTRACT NO. 15C-32B WAS ASSUMED BY RESOLUTION NO. 17R-01-09. ACCORDINGLY, THIS PROPOSAL WILL BE USED TO AID IN THE PURCHASE OF PLAYGROUND EQUIPMENT, SURFACING AND SHADE STRUCTURES FROM APPROVED VENDORS. STAFF IS RECOMMENDING APPROVAL OF THE SUPERIOR PARK SYSTEMS,

INC. PROPOSAL OF THE SCOPE OF WORK TO PROVIDE IMPROVEMENTS TO RUTH ROTHKOPH PARK. THE PROPOSED PROJECT ELEMENTS INCLUDE ONE (1) CUSTOM MEGA SPAN SHADE SYSTEM WITH "TURN-N-SLIDE" EASY STORM REMOVAL OF SHADE COVER CANOPY, PROFESSIONAL ENGINEERED-SEALED DRAWINGS, CALCULATIONS & PERMITTING, AND INSTALLATION. AS SUCH, THE PROPOSED SHADE STRUCTURE WILL COMPLEMENT AND ENHANCE THE RENOVATION OF THE PARK.
