## **Request Action:**

The Lauderhill Police Department requests approval from the City Commission to piggyback from the Miami-Dade Solicitation RTQ-02181 for the purchase of handguns and accessories from Lou's Police. Payment will be provided from the appropriate budget code.

**Need:** The contract will enable the city to purchase handguns and accessories to issue to all Police Officers to replace current handguns due to lifespan expiration.

### **Summary Explanation/ Background:**

The Miami-Dade contract will allow the city to purchase necessary handguns needed for the officers, the contract allows for the practice of "piggybacking", wherein cities may utilize the same pricing, terms and conditions. The vendor is Lou's Police. The quote in the amount of \$164,069.00 reflects the anticipated pricing after estimated trade-in values. It is recommended that the Commission approves the use of the Miami-Dade contract for the purchase of handguns to not exceed \$210,000.00 from Law Enforcement Trust Funds to accommodate for any difference in pricing due to estimated trade in values and additional accessories needed.
