

**RESOLUTION NO. 24R-08-159**

**A RESOLUTION APPROVING THE FINAL SETTLEMENT BETWEEN NAEH MEDIA GROUP, LLC/TK ENTERPRISES, INC. D/B/A TK ORIENTAL FINE FOODS AND THE CITY OF LAUDERHILL IN THE AMOUNT OF \$65,000.00 AS FULL AND FINAL SETTLEMENT OF ANY AND ALL CLAIMS INCLUDING ATTORNEY'S FEES AND COSTS RELATED TO ALL PARTIES; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, NAEH Media Group, LLC/TK Enterprises, Inc. d/b/a TK Oriental Fine Foods has filed a lawsuit against the City of Lauderhill; and

WHEREAS, the merits of the claim have been investigated by the City; and

WHEREAS, it is in the best interest of the City of Lauderhill that the matter be resolved;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the City Commission of the City of Lauderhill hereby approves the final settlement, including attorneys' fees and costs, in the amount of \$65,000.00 as full and final settlement between the City of Lauderhill and NAEH Media Group, LLC/TK Enterprises, Inc. d/b/a TK Oriental Fine Foods for any and all related claims.

SECTION 2. The City of Lauderhill will pay the total full and final settlement, including attorney's fees and costs at the trial level and on appeal, in the amount of \$65,000.00 to NAEH Media Group, LLC/TK Enterprises, Inc. d/b/a TK Oriental Fine Foods as full and final settlement of any and all claims, liens, fees, or costs against the City of Lauderhill.

SECTION 3. The City Manager and all other appropriate officials are authorized to execute settlement documents and all other documents necessary to fulfill the terms of this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
