Request Action:

Approve the ordinance on first reading.

Need Summary Explanation/ Background:

Per the City's Code of Ordinances, meter separation can only occur with City Commission approval. In an effort to be more efficient, it is recommended that the authority be given to the city manager because the act of separating meters is more of an administrative function than a policy making decision. The ordinance, if approved, will give authority to the city manager to allow separation of meters and to approve the remetering agreements.
