JULIUS GARVEY FOR HIS COMMITMENT TO PRESERVING THE LEGACY OF HIS FATHER, MARCUS GARVEY, AND HIS ADVOCACY FOR THE PARDON AND EXONERATION OF MARCUS GARVEY; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY MAYOR DENISE GRANT).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 2.</u> That the City Commission of the City of Lauderhill hereby awards a Key to the City Lauderhill to Dr. Julius W. Garvey in recognition of his unwavering commitment to preserving the legacy of his father, Marcus Garvey, and for his tireless advocacy for the pardon and exoneration of Marcus Garvey.
