This Resolution is to approve and accept the 2026 Florida Department of Transportation (FDOT) subgrant for Highway Traffic Funds in the amount of \$112,000 to be used for community education and enforcement programs to reduce speeding and aggressive driving crashes. The Grant is SC-2026-00397 Reducing Speeding and Aggressive Driving Through Community Education, Engagement and Enforcement. The City is not required to provide any matching funds. There is no match requirement.
