

**RESOLUTION NO. 25R-12-228**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE RELEASE AND USAGE OF STATE LAW ENFORCEMENT TRUST FUNDS TO DONATE TO THE BROWARD COUNTY HUMAN TRAFFICKING COALITION TO PROMOTE EDUCATION ON ISSUES OF HUMAN TRAFFICKING AT ITS ANNUAL COMMUNITY AWARENESS EVENT IN AN AMOUNT NOT TO EXCEED \$1,100.00; AUTHORIZING PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, the Broward County Human Trafficking Coalition (BHTC), which is a non-profit 501c3 organization that promotes education for law enforcement centered on human trafficking and on providing important resources to victims of human trafficking; and

WHEREAS, the City of Lauderhill Police Department is requesting use of State Law Enforcement Trust Funds in an amount not to exceed \$1,100 to assist with BHTC's annual community awareness event to be held on Saturday, January 26, 2026; and

WHEREAS, the use of these funds is in compliance with state law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The City Commission hereby authorizes the release and usage of the State Law Enforcement Trust Funds in an amount not to exceed \$1,100 to assist with promoting education on human trafficking at BHTC's annual community awareness event to be held on Saturday, January 26, 2026.

SECTION 2. That said payment shall be made from the appropriate budget code number(s).

SECTION 3. This Resolution shall take effect immediately upon its passage.
