A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE USE OF A COOPERATIVE PURCHASE OF RIFLE PLATES FROM GL DISTRIBUTOR, WHO IS THE SOLE SOURCE DISTRIBUTOR FOR GH ARMOR SYSTEMS FOR LAW ENFORCEMENT BODY ARMOR, BASED UPON THE STATE OF FLORIDA CONTRACT #46151500-NASPO-21-ACS (NASPO MASTER AGREEMENT #164713) FOR THE PURCHASE OF BODY ARMOR AND BALLISTIC RESISTANT PRODUCTS; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 305-321-06512 IN AN AMOUNT NOT TO EXCEED \$155,000.00; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH).

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the State of Florida has solicited bids (Contract #46151500-NASPO-21-ACS)(NASPO Master Agreement #164713) for the purchase of Body Armor and Ballistic Resistant Products; and

WHEREAS, the City of Lauderhill wishes to approve the purchase of Rifle Plates for use by the Lauderhill Police Department based upon the bids solicited by the State of Florida Contract; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The waiver of competitive bidding is hereby approved.

SECTION 2. The purchase of Rifle Plates from GL Distributors, the sole local distributor of GH Armor Systems for law enforcement, in an amount not to exceed \$155,000.00, based upon the bids solicited by the State of Florida (Contract #46151500-NASPO-21-ACS)(NASPO Master Agreement #164713) for the purchase of Body Armor and Ballistic Resistant Products, a copy of which is attached hereto and incorporated herein, is hereby approved.

SECTION 3. Payment in the total amount not to exceed \$155,000.00 shall be made from Budget Code Number .
