THIS APPROVAL WILL AUTHORIZE USER DEPARTMENTS TO ORDER UNCOOKED, PRECOOKED, OR PACKAGED FOOD PROVISIONS AND OTHER RELATED SUPPLIES SUCH AS, BUT LIMITED TO PLATES, NAPKINS, DISPOSABLE TABLECLOTHS, UTENSILS, CUPS, AND CLEANING SUPPLIES DURING HURRICANES AND ANY OTHER DECLARED STATE OF EMERGENCIES.

THE STATE OF FLORIDA ISSUED A SOLICITATION TO PROCURE A VENDOR TO PROVIDE EMERGENCY FOOD SERVICES DURING HURRICANES AS NEEDED. THE STATE RECEIVED FOUR PROPOSALS AND AFTER THE EVALUATION, THE CONTRACT WAS AWARDED TO CHENEY BROTHERS.
