I. REQUESTED ACTION

This Resolution is requested to approve the appointment to the P&Z, as selected by individual Commissioners to fill the vacant and/or expired seats.

II. SUMMARY AND HISTORY/BACKGROUND INFORMATION

The appointment of Ruth Lynch as regular board member, in association with seat 3, expired November 2024.

Vice Mayor Ray Martin has selected Ms. Lynch to be reappointed to the seat for the remainder of an unexpired term that lasts four (4) years, to expire November 2028 or concurrent with the Commissioner seat, whichever shall occur first.

III. FINANCIAL IMPACT

All board members receive a \$50.00 stipend, per meeting attended.

It is recommended that the Commission approve the appointments as described above.
