**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AUTHORIZING SETTLEMENT IN RICHARD DALEY V. THE CITY OF LAUDERHILL IN BROWARD COUNTY CASE NUMBER CACE24-004211, IN THE AMOUNT OF \$40,000.00 AS FULL SETTLEMENT FOR ANY AND ALL CLAIMS INCLUDING ATTORNEY'S FEES AND COSTS PLUS MEDIATION COSTS OF \$750.00; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).**

WHEREAS, claimant, Richard Daley filed a lawsuit against the City of Lauderhill for alleged injuries in Broward County, case number CACE-24-004211; and

WHEREAS, the City has investigated the claims and finds that settlement is warranted; and

WHEREAS, it is in the best interest of the City of Lauderhill to settle the lawsuit and authorize the City Manager and City attorney to do all things necessary to effectuate this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:**

SECTION 1. That settlement in the amount of \$40,000.00 plus \$750.00 in mediation costs between the City of Lauderhill and Richard Daley, in case number CACE-24-004211 is hereby approved as full and final settlement, and payment is authorized.

SECTION 2. The City Manager and City Attorney are authorized to to execute settlement documents and do all things necessary to effectuate this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
