## **RESOLUTION NO. 25R-09-166**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, RESCINDING RESOLUTION NO. 21R-03-59 TO ELIMINATE THE LAUDERHILL HEALTH AND PROSPERITY PARTNERSHIP ("LHPP") AS AN INITIATIVE OF THE CITY OF LAUDERHILL; PROVIDING FOR REPEAL; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY COMMISSIONER RICHARD CAMPBELL).

WHEREAS, by Resolution No. 21-03-59, adopted on March 8, 2021, the City Commission of the City of Lauderhill ("City") established LHPP as an initiative of the City to support health and wellness programs throughout the City; and

WHEREAS, the majority of the programs connected to LHPP are now being managed by the administration of the City, and the continuation of LHPP as an initiative of the City is no longer needed; and

WHEREAS, the City supports the creation of LHPP as a 501(c)(3) non-profit entity to be managed by its founders if the founders have a desire to establish LHPP as a non-profit entity to apply for funding from the City; and

WHEREAS, the administration of the City will manage all City grants connected to LHPP to ensure compliance with the grant agreements; and

WHEREAS, the City Commission of the City of Lauderhill finds it is in the best interest of the City to rescind Resolution No. 21R-03-59 to eliminate LHPP as an initiative of the City of Lauderhill.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

<u>SECTION 1.</u> The above recitations are true and hereby incorporated herein.

SECTION 2. The City Commission of the City of Lauderhill hereby rescinds Resolution No. 21R-03-59 to eliminate the Lauderhill Health and Prosperity Partnership ("LHPP") as an initiative of the City of Lauderhill.

<u>SECTION 3.</u> This Resolution appeals any prior action or Resolutions which authorize the City to create LHPP as a non-profit under Florida law.
