**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPOINTING \_\_\_\_\_ AND \_\_\_\_\_ BY THE CITY COMMISSION AS A WHOLE TO SERVE AS REGULAR MEMBERS OF THE CODE ENFORCEMENT BOARD TO FULFILL THE REMAINDER OF AN EXPIRED TERM THAT LASTS THREE (3) YEARS EXPIRING NOVEMBER 2027; APPOINTING RICHARD GAYLE BY COMMISSIONER RICHARD CAMPBELL TO SERVE AS AN ALTERNATE FOR THE REMAINDER OF A ONE (1) YEAR TERM THAT EXPIRES NOVEMBER 2025; APPOINTING JOHN BECKFORD BY MAYOR DENISE GRANT TO SERVE AS AN ALTERNATE FOR THE REMAINDER OF A ONE (1) YEAR TERM THAT EXPIRES NOVEMBER 2025, IF NOT CHOSEN AS A REGULAR BOARD MEMBER; AND PROVIDING FOR AN EFFECTIVE DATE.**

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. \_\_\_\_\_ and \_\_\_\_\_ are hereby appointed by the City Commission as a whole to serve as regular members to the Code Enforcement Board for the remainder of an unexpired term of three (3) years, expiring November 2027.

SECTION 2. Richard Gayle is hereby appointed by Commissioner Richard Campbell to serve as an alternate member of the Code Enforcement Board for a term that last one (1) year expiring November 2025.

SECTION 3. John Beckford is hereby appointed by Mayor Denise Grant to serve as an alternate member of the Code Enforcement Board for a term that last one (1) year expiring November 2025, if Mr. Beckford is not appointed as a regular member in section 1 above.

SECTION 4. This Resolution shall take effect immediately upon its passage.
