

RESOLUTION NO. 25R-12-236

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPOINTING VARIOUS MEMBERS OF THE LAUDERHILL COMMUNITY AND BUDGET ADVISORY BOARD BY THE CITY COMMISSION AS A WHOLE FOR POSITIONS THAT HAVE EXPIRED FOR THE TERMS PROVIDED; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Ordinance no. 23O-06-110 was passed to modify the geographic zoning map and thereby reducing the number of geographic areas to a total of seven (7) areas; and

WHEREAS, it was determined that the City of Lauderhill Community and Budget Advisory Board shall still be composed of a total of 11 members consisting of 9 regular members and 2 alternates, all appointed by the City Commission as a whole; and

WHEREAS, The City Commission wishes to appoint various individuals to fill expired positions for each zone as members of the Lauderhill Community and Budget Advisory Board for a two (2) year term, expiring July 2027 for sets 2, 3, 4, and 6 and for a one-year term for alternative positions expiring July 2026 (Seats 10 and 11).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the Lauderhill Community and Budget Advisory Board vacancy for Geographic Zone/Seat 2 shall be filled by _____, for the remainder of a two (2) year term to expire on July 31, 2027.

SECTION 2. That the Lauderhill Community and Budget Advisory Board vacancy for Geographic Zone/Seat 3 shall be filled by _____, for the remainder of a two (2) year term to expire on July 31, 2027.

SECTION 3. That the Lauderhill Community and Budget Advisory Board vacancy for Geographic Zone/Seat 4 shall be filled by _____, for the remainder of a two (2) year term to expire on July 31, 2027.

SECTION 4. That the Lauderhill Community and Budget Advisory Board vacancy for Geographic Zone/Seat 6 shall be filled by _____, for the remainder of a two (2) year term to expire on July 31, 2027.

SECTION 5. That the Lauderhill Community and Budget Advisory Board alternate vacancy for Geographic Zone/Seat 10 shall be filled by _____, for the remainder of a one (1) year term to expire on July 31, 2026.

SECTION 6. That the Lauderhill Community and Budget Advisory Board alternate vacancy for Geographic Zone/Seat 11 shall be filled by _____, for the remainder of a one (1) year term to expire on July 31, 2026.

SECTION 7. This Resolution shall take effect immediately upon its passage.
