Request Action:

Approval of a resolution authorizing the City of Lauderhill to enter into agreements, as needed, utilizing the State of Florida ACS Contract No. 31160000-25-NASPO-ACS, for the purchase of operational and janitorial supplies and solutions for use Citywide.

Need Summary Explanation/ Background:

Various divisions of the City of Lauderhill utilize operational and janitorial supplies and solutions, including cleaning and safety equipment and supplies, fixtures, hand/power tools and building materials, to maintain the beauty and safety of all City owned property and facilities.

The State of Florida has procured an Alternate Contract Source for the purchase of operational and janitorial supplies, based on the Lead State of Kentucky's competitive procurement resulting in executed Master Contract No. MA 758 2500000413. By utilizing the State of Florida ACS Contract No. 31160000-25-NASPO-ACS, the City is able to streamline procurement efforts, secure competitive pricing, and ensure full compliance with purchasing regulations.

Supplies and services under this contract will be purchased as needed, by the relevant Division, using the appropriate corresponding general ledger code.
