Permanent Changes (Ordinance Amendments):

1. **Amend Section 2-159** to rearrange the agenda and place quasi-judicial matters earlier in the meeting.
2. **Amend Section 2-157** to reduce the threshold for changing the order of business from four votes to a simple majority.
3. **Amend section 2-160** to allow consent items to be approved as a group without reading each item separately.

Need Summary Explanation/ Background:

The changes will provide for:

1. Efficiency: Streamlines the approval of routine or non-controversial items. Ensures critical items are addressed promptly and efficiently.
2. Fairness: Ensures quasi-judicial matters are heard promptly
3. Transparency: Expresses the Commission's intent to prioritize these matters in a permanent and predictable manner. Provides a mechanism for discussing specific items when necessary, maintaining transparency and public input.
4. Simplified Voting Requirements: A simple majority for changing the order of business increases flexibility for agenda adjustments.
