

**RESOLUTION NO. 26-01-01**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, WAIVING COMPETITIVE BIDDING REQUIREMENTS TO AUTHORIZE AN AGREEMENT WITH EMPIRE OFFICE, BASED ON A PIGGYBACK OF THE STATE OF FLORIDA ALTERNATE CONTRACT SOURCE NUMBER 56120000-24-NY-ACS FOR THE PURCHASE AND INSTALLATION OF FURNITURE AT THE LAUDERHILL POLICE STATION; AUTHORIZING PAYMENT IN AN AMOUNT NOT TO EXCEED \$537,000; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO ENTER INTO THE APPROPRIATE PIGGYBACK AGREEMENT AND TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, pursuant to Section 2-144 of the City's Code, the City of Lauderhill ("City") may waive its requirements on competitive bidding and join in on cooperative purchasing plans when in the best interest of the City; and

WHEREAS, the State of Florida Division of State Purchasing adopted an Alternative Contract Source ("ACS") number 56120000-24-NY-ACS to provide new commercial and institutional quality furniture of all types and entered an agreement with Steelcase, Inc; and

WHEREAS, Empire Office is an authorized dealer of Steelcase products; and

WHEREAS, the City, pursuant to section 2-144 of the City's Code, wishes to piggyback from the State of Florida ACS and enter into an agreement with Empire Office for the purchase and installation of furniture at the Lauderhill Police Station in an amount not to exceed \$537,000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitations are true and correct.

SECTION 2. The City is authorized to enter into an agreement with Empire Office, under the State of Florida ACS 56120000-24-NY-ACS in an amount not to exceed \$537,000 for the purchase and installation of furniture at the Lauderhill Police Station.

SECTION 3. The City Manager and City Attorney are authorized to enter into the appropriate piggyback agreement and do all things necessary to effectuate this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
