#### **Request Action:**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL ACCEPTING THE BID (#2024-025) OF INLINER SOLUTIONS IN AN AMOUNT NOT TO EXCEED \$777,888.00 TO PROVIDE SEWER LINING SERVICES TO SELECTIVE PORTIONS OF THE CITY'S WASTEWATER COLLECTION SYSTEM; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 401.917. 06392.

#### Need:

In an effort to reduce infiltration into the City's sanitary sewer system, the City plans to conduct sewer lining rehabilitation to the existing sanitary sewer lines in selective portions of the City. This process will repair and replace cracked, leaking, or damaged sewer lines within the City's sewer system. The sewer lining process will avoid the excavation of streets and reduces the restoration during construction.

#### Summary Explanation/ Background:

A NEED WAS RECOGNIZED FOR THE CITY TO OBTAIN A CONTRACTOR TO PROVIDE REHABILITATION SERVICES TO SELECTIVE PORTIONS OF THE CITY OF LAUDERHILL'S WASTEWATER COLLECTION SYSTEM. THE WORK TO BE PERFORMED SHALL CONSIST OF FURNISHING ALL TOOLS, EQUIPMENT, MATERIALS, SUPPLIES, AND MANUFACTURED ARTICLES AND FOR FURNISHING ALL TRANSPORTATION AND SERVICES, INCLUDING FUEL, POWER, WATER, AND ESSENTIAL COMMUNICATIONS, AND FOR THE PERFORMANCE OF AL LABOR, WORK, OR OTHER OPERATIONS REQUIRED FOR THE FULFILLMENT OF THE CONTRACT.
