A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING AN AGREEMENT WITH UNC LIFE ENTERTAINMENT, LLC, TO PROVIDE BOOKING AGENT SERVICES FOR THE ACQUISITION OF COMEDIC PERFORMERS, IN CONNECTION WITH LAUDERHILL LIVE LYRICS & LAUGHS 90S EDITION TO BE HELD SEPTEMBER 2026; AUTHORIZING THE EXPENDITURE IN THE NOT TO EXCEED AMOUNT OF \$62,000.00 FOR SERVICES AND EXPENSES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE SELECTED FIRM; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, the City of Lauderhill is in need of hiring a booking agent to provide booking agent services for the acquisition of comedic performers, in connection with Lauderhill Live Lyrics & Laughs 90s Edition to be held September 2026; and

WHEREAS, the City desires to engage UNC Life Entertainment, LLC., to provide booking agent services for the acquisition of comedic performers, in connection with Lauderhill Live Lyrics & Laughs 90s Edition to be held September 2026, in the not to exceed amount of \$62,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitals are true and incorporated herein.

SECTION 2. The City Commission hereby authorizes the City Manager to execute an agreement with UNC Life Entertainment, LLC to provide booking agent services in connection with Lauderhill Live Lyrics & Laughs 90s Edition to be held September 2026, in the not to exceed amount of \$62,000.00; subject to review and approval by the City Attorney.

SECTION 3. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
