A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE PIGGYBACK OF THE MIAMI-DADE SOLICITATION (RTQ-02181) FOR THE PURCHASE OF HANDGUNS AND ACESSORIES FROM LOU'S POLICE IN ORDER TO REPLACE POLICE OFFICERS' CURRENT HANDGUNS DUE TO THE EXPIRATION OF USEFUL LIFE; PROVIDING FOR PAYMENT IN THE TOTAL AMOUNT NOT TO EXCEED \$210,000.00 FROM BUDGET CODE NUMBER 120-683-9935; APPROVING THE EXPENDITURE FROM THE STATE LAW ENFORCEMENT TRUST FUNDS (LETF) ACCOUNT; PROVIDING FOR AN EFFECTIVE DATE; (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, Miami-Dade has solicited bids for the purchase of handguns and accessories and have selected Lou`s Police as the vendor; and

WHEREAS, the City of Lauderhill wishes to approve the procurement of handguns and accessories from Lou's Police based upon the bids solicited by Miami-Dade utilizing Law Enforcement Trust Funds; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The waiver of competitive bidding is hereby approved.

<u>SECTION 2</u>. The procurement of handguns and accessories from Lou`s Police, based upon the bids solicited by Miami-Dade (RTQ-02181), a copy of which is attached hereto and incorporated herein, is hereby approved subject to review and approval by the City attorney.

SECTION 3. The expenditure of funds in an amount not to exceed \$210,000.00 from the State Local Law Enforcement Trust Fund (LETF) to purchase new handguns and accessories to replace police officers` current handguns due to expiration of useful life, which is deemed an appropriate expenditure in accordance with law, is hereby approved.

SECTION 4. Providing that the expenditure in an amount not to exceed \$210,000.00 shall be paid from Budget Code Number 120-683-9935 and the appropriation of those funds to the necessary individual revenue and expenditure
