COMMUNITY REDEVELOPMENT AGENCY CITY OF LAUDERHILL

A RESOLUTION OF THE LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY APPROVING THE FISCAL YEAR 2025-26 BUDGET FOR THE CENTRAL COMMUNITY REDEVELOPMENT AGENCY IN THE TOTAL AMOUNT OF \$115,500.00; APPROVING THE FISCAL YEAR 2025-26 BUDGET FOR THE EASTERN COMMUNITY REDEVELOPMENT AGENCY IN THE TOTAL AMOUNT OF \$1,609,249.00; PROVIDING THAT BOTH OF THESE BUDGETS WILL BE INCORPORATED INTO THE CITY OF LAUDERHILL GENERAL OPERATING BUDGET FOR FISCAL YEAR 2026; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY EXECUTIVE DIRECTOR, SEAN HENDERSON).

WHEREAS, the local governing body of the City hereby approves the tentative budgets for the Eastern and Central Community Redevelopment Agencies (CRA) prior to the final adoption of the budgets by the CRA which will be held on September 29, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The budget for the Eastern Community Redevelopment Agency (CRA) for Fiscal Year 2026 commencing October 1, 2025 and ending September 30, 2026, in the amount of \$1,609,249.00 as approved by the CRA, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 2. The budget for the Central Community Redevelopment Agenda (CRA) for Fiscal Year 2026 commencing October 1, 2025 and ending September 30, 2026, in the amount of \$115,500.00, as approved by the CRA, a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 3. It is noted that the tentative budgets for both the Eastern and the Central CRA for Fiscal Year 2026 are incorporated as a part of the City of Lauderhill General Operating Budget for Fiscal Year 2026.

Section 4. This Resolution shall take effect immediately upon its passage.
