

**ORDINANCE NO. 240-12-162**

**AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL AMENDING THE CITY OF LAUDERHILL CODE OF ORDINANCES, CHAPTER 15, PARKS AND RECREATION, ARTICLE III, RECREATION FACILITIES FEES, SECTION 15-35, FEES, RULES AND REGULATIONS FOR REGISTRATION, USE AND RENTAL; APPROVING AN ALL-ACCESS MEMBERSHIP FEE FOR SENIORS AGE FIFTY-FIVE AND OVER (55+) FOR THE USE OF CERTAIN CITY FACILITIES/PROGRAMS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR.)**

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUERHILL, FLORIDA:

**SECTION 1.** That the City of Lauderhill Code of Ordinances Chapter 15-35 Parks and Recreation, Article III, Recreation Facilities Fees, Section 15-35, Fees, rules, regulations for registration, use and rental is hereby amended to read as follows:

**SECTION 2. Severability.** If any portion of this Ordinance is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Ordinance.

**SECTION 4. Conflict.** All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herewith be and the same are hereby repealed as to the extent of such conflict.

**SECTION 5.** This Ordinance shall take effect immediately upon its adoption.
