A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL PROVIDING PUBLIC NOTICE OF AND APPROVING AND ACCEPTING THE FUNDING AMOUNT FOR THE 2022 EDWARD BYRNE JUSTICE ASSISTANCE LOCAL SOLICITATION GRANT (JAG) MEMORANDUM OF UNDERSTANDING (MOU) IN THE AWARD AMOUNT OF \$48,905.00 BEFORE ADMINISTRATIVE FEES; APPROVING THE EXECUTION OF THE BROWARD COUNTY STANDARD SUB-RECIPIENT AGREEMENT AND THE SUBGRANT AWARD TERMS AND CONDITIONS AS WELL AN ANY OTHER NECESSARY DOCUMENTATION RETROACTIVELY; PROVIDING THAT NO MATCHING FUNDS ARE REQUIRED; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The City of Lauderhill hereby provides public notice of, approves and accepts the 2022 Edward Byrne Justice Assistance Local Solicitation Grant (JAG) Memorandum of Understanding (MOU) in the award amount of \$48,905.00 before administrative fees, a copy of which is attached hereto and incorporated herein.

Section 2. The City of Lauderhill hereby approves the Broward County Standard Subrecipient Agreement and the Standard Subgrant Award Terms and Conditions to be entered into with Broward County serving as Lead Agency and each of the subrecipient cities regarding the FY 2022 JAG Grant award, a copy of which is attached hereto and incorporated herein.

Section 3. The City of Lauderhill hereby authorizes the appropriation of funds to the individual revenue and expenditure accounts.

Section 4. The City Manager, and all appropriate City officials including the Police Chief, are authorized to execute the 2022 JAG Memorandum of Agreement (MOU), the Subrecipient Agreement and the Terms and Conditions, as well as any other documents necessary to fulfill the terms of this Resolution. Any documents that may have required earlier execution to meet necessary time deadlines are hereby approved retroactively.

Section 5. This Resolution shall take effect immediately upon its passage.
