



**SECOND AMENDMENT TO AGREEMENT BETWEEN  
BROWARD COUNTY AND THE CITY OF LAUDERHILL  
FOR INSTALLATION AND MAINTENANCE OF BUS SHELTERS**

This Second Amendment ("Amendment") is entered into between Broward County, a political subdivision of the State of Florida ("County"), and the City of Lauderdale, a municipal corporation (the "Municipality") (each a "Party" and collectively referred to as the "Parties").

**RECITALS**

A. The Parties entered into the Agreement between Broward County and City of Lauderdale for Installation and Maintenance of Bus Shelters, dated December 10, 2013 (the "Original Agreement"), to provide for the County's installation and City's maintenance of bus shelters.

B. The Original Agreement was amended by a First Amendment, dated March 16, 2023, which provided for the demolition of an existing bus shelter, installation of a temporary bus shelter improvement at a new location, and construction of a new permanent bus shelter. The Original Agreement, as amended by the First Amendment, is referred to herein as the "Agreement."

C. The Parties now desire to amend the Agreement to provide a current list of all bus shelters that Municipality has obligated itself to provide perpetual maintenance at its sole cost and expense pursuant to the Agreement and to identify additional bus shelters to be procured and installed by County, subject to Municipality's agreement to maintain these additional shelters at its sole cost and expense.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. The above Recitals are true and correct and are incorporated herein by reference. All capitalized terms not expressly defined within this Amendment shall retain the meaning ascribed to such terms in the Agreement.
2. Unless otherwise expressly stated herein, amendments to the Agreement made pursuant to this Amendment are indicated herein by use of strikethroughs to indicate deletions and bold/underlining to indicate additions. Except as modified herein, all remaining terms and conditions of the Agreement shall remain in full force and effect.
3. Exhibit A to the Agreement is hereby deleted and replaced with Exhibit A to this Amendment (bold/underlining omitted), which now identifies all bus shelters within Municipality (whether procured by County or others) as of the effective date of this Amendment that Municipality has agreed to perpetually maintain at its sole cost and expense in accordance with

the terms of the Agreement.

4. Municipality agrees to maintain any existing bus shelters not listed in Exhibit A that it adds amenities to after this Amendment is executed ("Prospective Bus Shelters"), and Municipality agrees to inform County within 15 calendar days of Municipality identifying such Prospective Bus Shelters. Municipality agrees to obtain all property access and permits and agrees to ensure ADA compliance and safety when installing Prospective Bus Shelters.

5. County agrees to procure and install at County's cost additional bus shelters within the jurisdictional limits of Municipality as shown in Exhibit B to this Amendment. Upon installation of each such additional bus shelter, Municipality agrees to perpetually maintain it at its sole cost and expense in accordance with the terms of the Agreement.

6. Municipality agrees to provide all property access, provide expedited review and approval of the permits, and waive all permit fees associated with the construction of the Bus Shelters identified in Exhibit B, as well as any future upgrades to Bus Shelters identified in Exhibits A and B.

7. If there is any conflict or ambiguity between this Amendment and the Agreement, the Parties agree that this Amendment shall control. The Agreement, as amended herein by this Amendment, incorporates and includes all prior negotiations, correspondence, conversations, agreements, and understandings applicable to the matters contained herein, and the Parties agree that there are no commitments, agreements, or understandings concerning the subject matter hereof that are not contained in the Agreement as amended in this Amendment. Accordingly, the Parties agree that no deviation from the terms hereof shall be predicated upon any prior representations or agreements, whether oral or written.

8. Preparation of this Amendment has been a joint effort of the Parties and the resulting document shall not, solely as a matter of judicial construction, be construed more severely against one of the Parties than any other.

9. Municipality acknowledges that through the date this Amendment is executed by Municipality, Municipality has no claims or disputes against County with respect to any of the matters covered by the Agreement.

10. The effective date of this Amendment shall be the date of complete execution by the Parties.

11. This Amendment may be executed in multiple originals or in counterparts, whether signed physically or electronically; each of which shall be deemed to be an original, and all of which, taken together, shall constitute one and the same agreement.
