Approval of a Booking Agent Agreement with UNC Life Entertainment, LLC, to provide booking agent services for the acquisition of comedic performers, in connection with *Lauderhill Live Lyrics & Laughs 90s Edition* to be held September 2026.

Need Summary Explanation/ Background:

The 2026 *Lauderhill Live Comedy Show* series includes a specialty themed show scheduled for September: *Lauderhill Live Lyrics & Laughs 90s Edition*. This themed show is headlined by comedian, actor, and television host Mark Curry (widely known for his television series *Hangin' with Mr. Cooper*) and hosted by comedian Marvin Dixon. The lyrical portion of the show is a homage to 90s Hip Hop and features the following musical acts:

- Richard Simpson (Chubb Rock)
- Edward K. Archer (Special Ed)
- Simone Risko (Monie Love)
- Kwame Holland (Kwame)
- Jeffrey Thompkins (JT Money)
- Willie Finch (Chill Will); DJ for Dougie Fresh.

As a result of this lineup, the amount of the show is \$62,000.00.
