

**RESOLUTION NO. 25R-08-161**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARDED THE KEY TO THE CITY OF LAUDERHILL TO EDDE CAMPBELL FOR HER DEDICATION AND COMMITMENT TO THE LAUDERHILL COMMUNITY; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY MAYOR DENISE D. GRANT).**

WHEREAS, Ms. Edde Campbell has dedicated her career to serving the most vulnerable members of our community with compassion, professionalism and steadfast integrity, specifically the residents of the City of Lauderhill; and

WHEREAS, through her leadership and operational expertise, Ms. Campbell established and managed seven residential facilities across Broward County, collaborating with public and private partners to support reentry and renewal initiatives; and

WHEREAS, Ms. Campbell proactively engaged in reentry efforts prior to the widespread adoption of formal programs, providing residents with opportunities for stability, personal development, and reintegration into the community; and

WHEREAS, Ms. Campbell consistently served the homeless population by coordinating and delivering essential meals and services on a regular basis for more than twenty years, and when capacity constraints arose, she identified and implemented alternative solutions to meet Demand; and

WHEREAS, even after retirement, Ms. Campbell's commitment to service continues, including the disposition of her final residence at 3764 NW 2nd Street to a beneficiary rebuilding her life, a gesture recognized by the dedication of the property in Ms. Campbell's honor as a lasting testament to her generosity and dedication to renewal and opportunity; and

WHEREAS, the City Commission has determined that Ms. Campbell's sustained leadership and impact on public welfare merit formal recognition by the City of Lauderhill.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:**

SECTION 1. That the City Commission of the City of Lauderhill hereby awards a Key to the City of Lauderhill to Edde Campbell in recognition and acknowledgment of her sustained leadership, transformative service, and enduring commitment to creating opportunity and hope for those most in need.

SECTION 2. That the City Commission of the City of Lauderhill presents a copy of this Resolution to Edde Campbell as a symbol of the City's appreciation for her remarkable contributions to the community of Lauderhill.

SECTION 3. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
