SUBJECT: Fee Waiver Request – 2025 Cricket Games at Central Broward Park

Sponsorship Recommendations

The global popularity of T20 cricket continues to grow, and the City of Lauderhill is committed to seizing the opportunities presented by hosting the upcoming nine (9) T20 matches scheduled to be held at the Broward County Cricket Stadium, located within the City. Staff has conducted an analysis of the total cost to the City to host these games and as such a recommendation of a total waiver of \$97,502.11 is being proposed.

The breakdown is as follows:
