Need Summary Explanation/ Background:

To protect the City in the pursuit of first and third-party claims based on the following losses: General Liability, Property, Auto Liability and Physical Damage, Workers' Compensation, Boiler & Machinery, Errors and Omissions, Law Enforcement, Inland Marine, Crime, Employers Liability and Sexual Misconduct.

Cost Summary/ Fiscal Impact:

The fiscal year 2024-2025 premiums are \$2,284,373, representing a \$290,976 (14.60%) increase. These premiums are budgeted in our 162 accounts.
