

**RESOLUTION NO. 24R-11-279**

**A RESOLUTION APPROVING THE WAIVER OF COMPETITIVE BIDDING; APPROVING THE COOPERATIVE PURCHASE FOR THE SUPPLY OF AGGREGATES, TOP SOIL AND SAND BASED UPON BASED UPON THE BIDS SOLICITED BY THE CITY OF MARGATE ACTING AS "LEAD AGENCY" FOR THE SOUTHEAST FLORIDA GOVERNMENT PURCHASING COOPERATIVE MULTIPLE AWARD BID #2022-006; SECURING PRICING ON AN AS NEEDED BASIS; PROVIDING FOR PAYMENT FROM APPROPRIATE BUDGET CODE NUMBERS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Margate acting as "lead agency" for the Southeast Florida Government Purchasing Cooperative Multiple Award Bid #2022-006 secured the pricing for aggregates, top soil and sand; and

WHEREAS, the City Commission has determined that the piggyback of the Southeast Florida Government Purchasing Cooperative on an as needed basis, would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The waiver of competitive bidding is hereby approved.

SECTION 2. The cooperative purchase of aggregates, top soil and sand based upon the bids solicited by the City of Margate acting as "lead agency" for the Southeast Florida Government Purchasing Cooperative Multiple Award Bid #2022-006 cooperative pricing on an as needed basis, a copy of which is attached hereto and incorporated herein, is hereby approved.

SECTION 3. Payment as needed shall be made from the appropriate Budget Code Numbers on an as needed basis.

SECTION 4. This Resolution shall take effect immediately upon its passage.
