<u>Section 1.</u> The tentative Property Tax Levy for the Windermere/Tree Gardens Safe Neighborhood Improvement District by the City of Lauderhill to be collected by the Broward County Property Appraiser's Office as the uniform method of collection on the Annual Tax Bill for fiscal year 2026 at the millage rate of 2.0 Mills, is hereby approved.

<u>Section 2.</u> The tentative non-ad valorem assessment in the amount of \$500.00 per parcel of land per year within the District is hereby approved.
