

**RESOLUTION NO. 26R-03-65**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, ACCEPTING THE CERTIFIED RESULTS OF THE MARCH 10, 2026 SPECIAL ELECTION FROM THE BROWARD COUNTY CANVASSING BOARD, BROWARD COUNTY SUPERVISOR OF ELECTIONS OFFICE, REGARDING THE ISSUANCE OF NOT EXCEEDING SIXTY-FIVE MILLION DOLLARS (\$65,000,000) OF GENERAL OBLIGATION BONDS; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, the City of Lauderhill City Commission passed Resolution No. 25R-12-240, authorizing three ballot questions to be submitted to the electors of the City at a bond referendum election/special election to be held on March 10, 2026; and

WHEREAS, the ballot questions were regarding the issuance of general obligation bonds not exceeding \$65,000,000, for public safety projects, parks improvements projects, and transportation and roadway projects; and

WHEREAS, the Supervisor of Elections has presented the City with the certified results of the March 10, 2026 referendum/special election, to wit:
