

RESOLUTION NO. 25R-12-238

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARDED RFP 2025-040 – DRUG AND ALCOHOL TESTING SERVICES TO DSI MEDICAL SERVICES, INC. AND CARESPOT URGENT CARE FOR THE PURPOSE OF CONDUCTING DRUG AND ALCOHOL TESTING OF CITY EMPLOYEES; AUTHORIZING THE CITY MANAGER TO ENTER INTO AGREEMENTS WITH THE SELECTED VENDORS; FURTHER AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, the City of Lauderhill recognizes the importance of maintaining a safe and drug-free workplace for all employees; and

WHEREAS, the City's Human Resources Department requires access to reputable, State of Florida–certified laboratories or hospitals capable of conducting urine and/or blood specimen testing for drug and alcohol use; and

WHEREAS, such testing services are essential for compliance with City policies and for administering reasonable suspicion and post-accident testing as needed; and

WHEREAS, the Purchasing Division issued RFP 2025-040 – Drug and Alcohol Testing Services to establish a list of qualified vendors to provide these services on an as-needed basis; and

WHEREAS, the evaluation committee reviewed the proposals received and recommends award to DSI Medical Services, Inc. and CareSpot Urgent Care, both meeting all requirements and qualifications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitals are true and incorporated herein.

SECTION 2. The City Commission hereby awards RFP 2025-040 – Drug and Alcohol Testing Services to DSI Medical Services, Inc. and CareSpot Urgent Care, and authorizes the City Manager to execute agreements with the selected vendors for the provision of employee drug and alcohol testing services as needed.

SECTION 3. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
