I. Introduction

This Request to Qualify (RTQ) will establish a pool of pre-qualified vendors capable of providing/delivering law enforcement equipment and supplies for Miami-Dade County (MDC). Entry into the Prequalification Pool is not a contract between MDC and any member of the pool, but rather is an acknowledgement that the pool member satisfies the pre-qualification criteria set forth below for inclusion in the pool. Pre-qualified vendors will be invited to participate in future Request for Quotations (RFQ).

The pool shall remain open for the duration of this term, enabling new vendors to qualify at any time after the commencement date.

II. Spot Market Quote Procedures:

Future spot market competition(s) may be conducted by the County through the following processes:

a. Invitation to Quote (ITQ): award based on the lowest price offered.

Prior to issuance, all Spot Market Quotes must be submitted to the Small Business Division for review and application of the measures. Please provide an overview of your project to the Small Business Division: sbdprp@miamidade.gov to determine what contract measures are recommended for your particular project.

All pre-qualified vendors will be solicited for price and availability as needed. All quotations issued must be registered with the Small Business Development Division at the following link: https://intra8.miamidade.gov/Apps/ISD/SBD/Login.aspx. This link officially places your project on the Cone of Silence Report.
