BE IT RESOLVED BY THE CITY OF LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY, THAT:

SECTION 1. The Agreement between the City of Lauderhill and UNC Life Entertainment to provide booking agent services for the following comedic performances: Marvin Dixon (host), Bill Bellamy, Adele Givens, and Kiana Dancie in connection with the September 28, 2024 Lauderhill Live event, a copy of which is attached hereto and incorporated herein, is hereby approved, subject to review and approval by the City Attorney.

SECTION 2. The CRA Executive Director and all appropriate city officials are authorized to execute this Agreement and any other documents required to fulfill the terms of this Resolution, and any documents that required execution prior to the date of this Resolution are hereby retroactively approved.

SECTION 3. Providing that payment in the amount of \$55,500.00 shall be paid from the appropriate CRA budget code number(s).

SECTION 4. This Resolution shall take effect immediately upon its passage.
