

**RESOLUTION NO. 23R-06-159**

**A RESOLUTION APPROVING EMERGENCY REPAIRS TO GRAVITY SEWER MAIN SYSTEMS AND SEWER LATERALS IN THE TOTAL AMOUNT NOT TO EXCEED \$78,675.00 PAID TO THE EMERGENCY CONTRACTOR MADSEN BAR AS A RESULT OF SINKHOLES RELATED TO RECENT FLOODING; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 401-917-6320; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, in April 2023, the City of Lauderhill experienced a severe rain event which resulted in extreme flooding in certain areas; and

WHEREAS, the flooding resulted in Infiltration which can cause the surrounding soil to erode and wash away creating voids or empty spaces beneath the surface of the ground, which can cause the ground to collapse and create a sinkhole; and

WHEREAS, the City Utilities Department located two sinkholes that were located which necessitated emergency repairs to the sewer gravity mains and sewer laterals located at N.W. 49<sup>th</sup> Avenue/17<sup>th</sup> Court and the 1800 block of N.W. 38<sup>th</sup> Avenue; and

WHEREAS, the necessary gravity sewer main emergency repairs resulted in the amount of \$78,675.00;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The proposal from Madsen Bar the amount of \$78,675.00 for the emergency repair to the City's gravity sewer main system and sewer laterals located at N.W. 49<sup>th</sup> Avenue/17<sup>th</sup> Court and the 1800 block of N.W. 38<sup>th</sup> Avenue, as a result of damage caused by flooding, a copy of which is attached hereto and incorporated herein, is hereby approved.

SECTION 2. Providing for payment in the total amount not to exceed \$78,675.00 from Budget Code Number 401-917-6320.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.
