

RESOLUTION NO. 23R-06-131

A RESOLUTION APPROVING THE STORMWATER SERVICES AGREEMENT BETWEEN THE CITY OF LAUDERHILL AND FOREST LAKE ESTATES HOMEOWNER`S ASSOCIATION PROVIDING FOR LIMITED STORMWATER MAINTENANCE SERVICES FOR THE BETTERMENT OF THE CITY`S OVERALL STORMWATER MANAGEMENT SYSTEM; AUTHORIZING ACCESS TO THE PRIVATE PROPERTY FOR THE PURPOSE OF SAID LIMITED MAINTENANCE; PROVIDING TERMS AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, The City of Lauderhill collects Stormwater User Fees which are a separate and distinct Stormwater Enterprise Fund which are solely designated to be used for expenditures associated with the stormwater system, and which are distinguishable from tax revenues or public funds; and

WHEREAS, this Agreement does not provide for the use of any tax revenues or public funds to be spent for the limited stormwater maintenance services to be provided to private property and no public funds will be utilized to provide these services; and

WHEREAS, this Stormwater Services Agreement provides for limited stormwater maintenance to be provided using solely Stormwater User Fees Enterprise funding; and

WHEREAS, The Forest Lake Estates Homeowner`s Association approved this Agreement at their April 27, 2023 Board Meeting;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The Stormwater Services Agreement between the City of Lauderhill and Forest Lake Estates Homeowner`s Association to provide for limited stormwater maintenance services for the betterment of the City`s overall stormwater management system and utilizing solely Stormwater User Fees Enterprise Funding, according to the terms and conditions stated therein, a copy of which is attached hereto and incorporated herein, is hereby approved.

SECTION 2. The City Manager and all appropriate city officials are authorized to execute this Agreement and any other documents required to fulfill the terms of this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
