**Need Summary Explanation/ Background:**

House Bill 393 and Senate Bill 450 intend to remove the monetary cap on the amount of an ad valorem tax exemption that may be transferred to the surviving spouse upon the purchase of a new Homestead property, and revise the dates from which a surviving spouse may be able to claim the exemption upon the purchase of a new Homestead property.
