

**RESOLUTION NO. 25R-08-149**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AUTHORIZING SETTLEMENT OF CLAIMS BROUGHT BY JEAN LABISSIERE AGAINST THE CITY OF LAUDERHILL IN THE AMOUNT OF \$60,000.00 AS PAYMENT FOR ANY AND ALL CLAIMS INCLUDING ATTORNEY'S FEES AND COSTS; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY HUMAN RESOURCES DIRECTOR, ERCILIA KREMPLER AND CITY MANAGER, KENNIE HOBBS, JR.).**

WHEREAS, Jean Labissiere has filed a claim against the City of Lauderhill alleging injuries;  
and

WHEREAS, the City has investigated the claims and finds that settlement is warranted;  
and

WHEREAS, it is in the best interest of the City of Lauderhill to settle all claims with Jean Labissiere and authorize the City Manager and City attorney to do all things necessary to effectuate this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, THAT:**

SECTION 1. The settlement of all claims with Jean Labissiere in the amount of \$60,000, which includes attorneys fee and costs, is hereby approved.

SECTION 2. The City of Lauderhill will pay the total and final payment for the fees and costs in the amount of \$60,000.00 to Jean Labissiere, on behalf of himself, and any and all heir of his, assigns, or successors as full and final settlement on any and all claims, liens fees, or costs against the City of Lauderhill.

SECTION 3. The City Manager and City Attorney are authorized to execute settlement documents and all other documents necessary to fulfill the terms of this Resolution.

SECTION 4. This Resolution shall take effect immediately upon its passage.
